Distance from expert medical care:

Maroondah Hospital is 15km away. Mt Evelyn Medical Clinic is 1.5km away and Ambulance Victoria are easily accessible.

Accommodation arrangements:

The students will be staying in cabin style accommodation with boys and girls sleeping in separate cabins.

Travel arrangements:

The students will be driven by bus to the camp. Parents are to collect their children at the conclusion of the camp: 2.30pm

Adventure activities to be undertaken or that may be offered to students throughout the program: Archery, Low Ropes Course, Flying Fox, Initiatives Course.

Activities within this program present the potential for students to sustain physical injury.
